Powers & Functions of Discipline Committee

The Committee shall have the following powers and functions:

1. To consider the confidential reports of the members of the University staff and recommend confirmation, incentive or punishment etc., to the competent authority.
2. In case of misconduct of the teachers of the University and breach of conditions of the agreement, it will conduct an enquiry in accordance with the terms of the agreement executed by them and make its recommendations to the Board of Management.
3. In cases of misconduct on the part of non-teaching staff, it will conduct an enquiry and make its recommendations to the Board of Management / president.
4. In cases of indiscipline on the part of the students of the University.
5. A sub-committee shall be constituted for specific incidents to enquire into the incidents giving a fair hearing to both accused, affected and their parents. The sub-committee shall submit the report to the Discipline Committee which will go through the report and forward the same to Vice-chancellor along with recommendation for his approval. The Registrar has to execute the order of Discipline Committee as approved by president.

The Registrar has to execute the order of the Discipline Committee as approved by the president.
